1. Old Business

Adopt minutes – Mr. Shade asked for the minutes of the Jan meeting be presented to the Board for adoption. Gary Roach moved to adopt the minutes and it was seconded by Mr. Shade. It passed unanimously.

Financial decision about field trip to Castles and Coasters. Mr. Shade announce that he personally visited the Castles and Coasters and agreed that it looked like a good place for our students to enjoy. He further announced that he made arrangements for the park to open just for our Crown Students and we would have the entire park to ourselves. The cost would be \$20.00 per student and he moved that the school pick up the entire cost which would be mostly covered by the student activity fee. The motion was seconded by Mr. Runyan. 2. New business

Teaches reported that the outside community was pleased with their contact with them.
